- Explain who needs a LOC (level of care) review and the information required to process a LOC for a hospital or nursing facility resident (i.e., payer change or transfer).
- Discuss who qualifies for a "hospital exemption" (ODJFS 7000) and the implications for the admitting nursing facility.
- List the requirements for admission to a nursing facility from the community for both Medicaid and non-Medicaid clients.

★ **COAAA - 174 E. Long Street**



Route I-71 to the Broad Street exit. West on Broad Street to 4th Street. North on 4th Street two blocks. The Central Ohio Area Agency on Aging (COAAA) is at the northeast corner of northbound 4th Street and eastbound Long Street.

Parking is available at a variety of lots within a two-block radius. Cost is between \$3.50 and \$8.00 for the day. Some lots require exact change. (The COAAA parking lot is for staff only.) There is no free parking in downtown Columbus.
