| Assisted Living Waiver | Provides care for Medicaid-eligible adults in an approved assisted living facility. | Next Generation MyCare | Provides care for Medicare and Medicaid-eligible adults in their homes or in an approved assisted living facility. An alternative for people needing more care, but not in a nursing home. | A managed care organization oversees healthcare. Services are similar to PASSPORT and include medical care, long-term care, behavioral health services, as well as care coordination. COAAA provides in-home waiver service coordination. | | <ul style="list-style-type: none"> • 21 years of age or older • Have qualifying functional impairments (need assistance with bathing, meals, etc.) • Medicare eligible • Medicaid-waiver eligible* |
| Franklin County Senior Options (FCSO) | Homecare program funded by the Franklin County Senior Services Levy. | Caregiver Support Program | Provides free, short-term supportive services for non-paid caregivers of older adults, parents caring for an adult with a disability, or someone caring for non-biological children. | <ul style="list-style-type: none"> • Adult Day Services • Caregiving Counseling • Durable Medical Equipment • Incontinence Supplies • Kinship Supportive Services • Respite Care | | <ul style="list-style-type: none"> • Non-paid caregivers of older adults 60+ years old • Non-paid parents or relatives 55 years and older caring for an adult child with a disability • Kinship caregivers 55 years and older who are caring for non-biological children (Franklin County only) |

* Medicaid Waiver programs help provide long-term care services in the community to people who would otherwise be in an institution or nursing home.

| Care Transitions | Connects individuals who have recently been discharged from the hospital to needed services. | Veteran-Directed Care | Provides veterans of all ages the opportunity to receive in-home services and empowers the veteran to determine who provides their care. | <ul style="list-style-type: none"> • Personal Care • Meal Preparation • Homemaking • Medication Assistance • Transportation • Case Management | No age or income requirements; be enrolled in the VA healthcare system; meet clinical need for in-home services; ability to direct their own care; may hire family or friends to provide care. |

| Medicare Outreach | Free services from knowledgeable staff who educate individuals and groups about Medicare. | Long-term Care Consultations | A free, customized consultation that helps individuals understand how to meet current or future long-term care needs. | Information about long-term care services and supports that help individuals in maintaining their independence. | No age or income requirements |
| Wellness Programs | Wellness presentations and falls management workshops. | <ul style="list-style-type: none"> • Matter of Balance - 8 sessions • Healthy, Well & Wise - one-hour sessions | No age or income requirements |
| Volunteer Guardian Program | Recruits, screens, trains, and supports volunteer guardians of the person for adults who lack medical decision-making capacity and who live in a group care setting. | <ul style="list-style-type: none"> • Volunteers are appointed by the county probate court as guardians of the person • Volunteers are trained and supported in their role by COAAA staff • Volunteers are not financially responsible for the person they serve and do not handle money | Serves vulnerable residents who lack decision-making capacity at nursing homes in Delaware, Fairfield, Fayette, Franklin, Licking, and Pickaway counties. |
