

COAAA Seeking ARPA Proposals

The Central Ohio Area Agency on Aging is pleased to announce the availability of funding for American Rescue Plan (ARPA)/Title III programs. These funds will be awarded beginning July 1, 2023, until September 30, 2024. Approximately **\$3,022,483.00** in funding for ARPA/ Title III Services is available for Delaware, Fayette, Fairfield, Franklin, Licking, Madison, Pickaway, and Union counties. Allocation amounts are based on projected state and Federal budgets and are subject to change.

To be considered, the proposal must include all of the required documents, including the general applicant demographics form and addendum. Applicants are encouraged to submit innovative proposals to address the needs of older adults in Central Ohio as identified in COAAA's [2023-2026 Strategic Area Plan](#).
